

Dr Guillermina Natera and Dr Marcela Tiburcio:

The 5-Step Method program in rural Mexico: from cultural adaptation to efficacy and cost-effectiveness evaluation

This Keynote talk will describe the process followed to culturally adapt the 5-Step Method program using Ethnography-based methods to gain access to the community. We will comment on the use of other qualitative techniques such as cognitive laboratories and the use of vignettes to validate educational materials. Later, we will delve into the description of the study to evaluate the efficacy and cost effectiveness of the adapted program, and how it changed women's perspectives.

Professor Jim Orford:


Mainstreaming work with Affected Family Members: How far have we come and how far have we still to go?

This Keynote talk will look back over 50 years of work on addiction and the family. In doing this, Jim will argue that much progress has been made in understanding the experiences of concerned and affected family members (CAFMs) and developing ways of helping them. But progress has been slow and CAFMs remain marginalised in health services and in research. Jim will suggest a number of possible ways in which this state of affairs might be improved.

Professor Jim Orford, PhD

Professor Jim Orford, PhD, Emeritus Professor of Clinical and Community Psychology, University of Birmingham, UK.
Professor Orford has been an active researcher since the 1960s, and shows no signs of slowing down! One of his many areas of research has been Addiction and the Family, initially focusing on alcohol, then adding drugs, and

She was part of the team which started research on addictions and mental health in Mexico in the 1970s; community research in both urban and indigenous settings has been her main interest. Supported by WHO in 1988, Jim Orford spent his sabbatical in Mexico City, and with him, Dr Natera initiated family-oriented research with a new perspective, which led to extensive studies on the subject and to the development of intervention programs based on the stress-coping model, to support both urban and indigenous groups. We also developed strategies to train health professionals on the intervention programs. From 2008 to 2018, she was Director of Epidemiological and Psychosocial Research at the National Institute of Psychiatry; currently she is Researcher Emeritus by the National System of Researchers in Mexico.

Dr Marcela Tiburcio, PhD, Head of the Department of Social Sciences in Health, Ramón de la Fuente Muñiz, National Institute of Psychiatry in Mexico City, Mexico, member of the National System of Researchers level 2.

Dr Tiburcio trained in addiction psychology, and is professor of the postgraduate program in Psychology at the National Autonomous University of Mexico, as well as holding the positions outlined above. She has worked in the field of substance use for more than 25 years; her topics of interest are: a) family mental health in urban and indigenous population, b) development, evaluation and implementation of brief interventions and, c) the use of technology for substance use care. She is a member of AFINet, and representative of INEBRIA Latina.
